In continuation to this Council's Letter of Intent No. 51/2010 number dated 07.07.2010 and with reference to your letter No. SMJ/SMEJ/MCI/2010/2272 dated 07.07.2010, I am directed to convey the approval of the Board of Governors for establishment of a new medical college at Jorhat, Assam in the name and style of "Jorhat Medical College & Hospital, Jorhat" by Society for Medical Education, Jorhat with an annual intake of 100 (One Hundred only) students with prospective effect i.e. from the academic year 2010-11 u/s 10 (A) of the IMC Act, 1956, as amended.


This permission of the Board of Governors, Medical Council of India for establishment of new medical college and admission of students is initially for a period of one year. It will be renewed on yearly basis on verification of achievements of annual target set out in the project report. This process of annual renewal of permission will continue till such time the establishment of medical college and expansion of hospital facilities are completed as per the norms of Medical Council of India.

I am further directed to inform that you and your institution are fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material, etc. Throughout the academic year, as stipulated in Regulation of Medical Council of India. In case false/wrong declaration or fabricated documents have been used for procuring permission of the Board of Governors and the said misconduct is brought to notice or comes to the knowledge of MCI at any stage during the current academic year, your institution is not liable to be considered for renewal of permission for the next academic year and this letter of permission is also liable to be revoked for current academic year. Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.

The college shall not admit more than one batch of students against this letter of permission. The college shall also apply to Medical Council of India for renewal of permission well before the commencement of next academic session. While applying for such renewal, the achievements in terms of infrastructure, staff and equipments as spelt out in the time bound action plan and as per the norms by Medical Council of India, must be clearly indicated. The next batch of students shall not be admitted unless renewal of permission is granted by the Board of Governors, Medical Council of India/Central Government.

This permission is subject to the Bank Guarantee of Rs. 7.00 crores (Rupees 1.50 crores towards medical college and 5.50 crores towards hospital facilities) furnished by Society for Medical Education, Jorhat, for the establishment of new medical college and hospital found to be adequate / genuine on all counts. The admission process for the academic year 2010-11 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulation, 1997, as amended.
